DOG LICENSES

Dog owners are required to renew their licenses annually at the Clerk-Treasurer's January through March 31st. The cost is \$10 per dog with a maximum of three dogs permitted at each residence. After March 31st, the cost will be \$15 per dog. A valid rabies certification is required in order to renew the license. For those who are unable to come to the Town Hall to renew the dog license, we will accept a copy of the valid rabies certificate, and payment by check, through the mail or the drop box in our parking lot. Snow Removal Responsibilities

Town: Maintains, plows, and salts public streets and roadways.

Residents: Clear snow and ice from private driveways and adjoining sidewalks.

Recommended Actions

Clear your driveway: Use a shovel or snow blower to remove snow after plows have completed their route. Do not put back in the street, tickets can be written

Clear sidewalks: Keep the sidewalks adjacent to your property free of snow and ice to ensure safe pedestrian passage.

If you are unable to perform the physical tasks of shoveling or snow blowing your driveway and sidewalk, please consider seeking assistance from friends, family, neighbors, or hiring a professional snow removal service to ensure access is maintained during inclement weather

CONTRACTOR'S LICENSE RENEWAL

Contractor's License Renewals Starting January 1, 2026 until March 1, 2026, the Town of Cedar Lake is accepting Contractor's License renewal applications. The renewal fee is \$50.00 along with your renewal application, a copy of your recorded Lake County bond, a copy of your certificate of insurance with Workman's Compensation, and a copy of your Lake County License (General Contractor's only). SNOW ROUTE PARKING:

Per Town Ordinance 72.32: In the Event of any falling snow, sleet, or freezing rain, occurring within the Town, at any time, a parking prohibition on all snow emergency routes in the town shall immediately be in effect. Once in effect, this shall remain until the snow, sleet, or freezing rain has been cleared entirely. 72.39: All streets or portions of streets within the town are hereby designated as snow emergency routes.

But if you must go out remember to adjust your speed for the driving conditions:

- Always wear your seatbelt.
- Accelerate and decelerate slowly, it takes longer to slow down on icy roads.
- Allow extra space between you and other vehicles.
- Make sure your tires are properly inflated.
- Do not use cruise control when driving on any slippery surface.
- Keep your gas tank at least half full, to avoid the gas line freezing up.
- Always carry your charged cell phone.
- Also keep extra hats, gloves, food, water and blankets in your car.
- If you do become stranded, stay with your vehicle. Never try to walk in a storm.
